Welcome to The Spine Practice of Dr. Johnson and his team of staff and colleagues who you will meet at your appointment! Please read and complete your New Patient Packet for us to begin scheduling your appointment.

When the Packet is completed along with the reports of your imaging studies (X-Rays, MRI's and CT's) please return to our office by, fax, email or regular mail to our office. Once you have returned the completed Packet and have your imaging reports we will coordinate an appointment for you. We suggest you make a copy of the Packet you submitted and bring it with you with any pertinent medical records you wish Dr. Johnson to review. Please note that appointment scheduling for Dr. Johnson can be as long as 4-6 weeks. If there is an urgent need for an earlier appointment please have your referring doctor contact our office at 310.423.9792 to request an earlier appointment.

INSURANCE PAYMENTS

Dr. Johnson accepts patients with all insurance however he is not a contracted provider for most medical insurance. We accept most insurance as partial payment, and you may be responsible for a portion of your bill for both consultation and surgery. The initial consultation fee is \$500 and is due on the day of your first visit. Methods of payment accepted are: credit card, check or cash. Your insurance may pay a portion of the initial consultation fee and you will be refunded the amount that your insurance pays directly to us. Follow up visits are \$100.00 (excluding post-operative visits for the 90 days after surgery).

Dr. Johnson is not a Medicare provider, but he does provide consultation and surgical care to Medicare patients. The initial consultation fee for Medicare patients is \$400.00 and follow up visits are \$100.00 (excluding post-operative visits for the 90 days after surgery). If surgery is needed, a fee schedule for your procedure is provided.

Worker's Compensation patients are seen in consultation and surgery, with accepted Worker's Compensation fee schedules.

Surgical fees are provided in a fee schedule provided by our office that will need to be both approved and agreed upon prior to surgery. Surgical fees are paid prior to surgery or by arrangement with our billing agency Mednet Billing, Inc. The contact person at Mednet Billing, Inc. is Mariela at 310.322.4278 extension 1112.

MISSED APPOINTMENT POLICY

If you are unable to make your scheduled appointment please contact us within 24 hours of your appointment at **310.423.9792**. Those patients who do not contact us will be charged \$75.00 for a missed appointment. Insurance companies DO NOT pay for missed appointments.

ARRIVING LATE FOR AN APPOINTMENT

If you are late to your appointment you are allowed a 15 minute grace period. If you have not contacted the office informing us of any delays longer than 15 minutes you will be considered a "missed appointment" and you will need to re-schedule your appointment.

Note: It is mandatory all New Patients hand carry their most current (within 12 month's) CD's, Films, MRI or CT scans to their appointment. You will need to be rescheduled if you do not bring them.
